

Hickory Log Creek Reservoir | Canton, Georgia 30114 Annual Parking Permit Application

The Hickory Log Creek Reservoir is a drought contingency reservoir owned and operated by the City of Canton and the Cobb County-Marietta Water Authority. The sole purpose of the reservoir is to maintain a backup water supply for the customers of the City and Authority during drought conditions that result from low flows in the Etowah River and ultimately lake levels in Lake Altoona. During these times of low flow, water will be released from the reservoir to supplement flow in the Etowah River. As a result, reservoir levels are subject to fluctuation and water levels may drop below the boat ramp level.

- 1. All Georgia Department of Natural Resources Rules & Regulations for water safety are in effect (i.e. boat registration, life jackets, fishing license, etc.)
- 2. Boats are allowed but restricted to electric powered only, canoes, and kayaks. Boats with gas or diesel motors and sail boats are not allowed on the reservoir.
- 3. All boats must be out of the water and loaded 15 minutes before closing time.
- 4. Swimming is not allowed at the Reservoir.
- 5. Alcoholic beverages are strictly prohibited.
- 6. Firearms of are strictly prohibited.
- 7. Stay clear of dam and spillway.
- 8. The City of Canton assumes no responsibility for injury or death of anyone which occurs on the property of the City, absent its gross negligence. Users of premises do so at their own risk.
- 9. The City of Canton reserves the right, at its discretion, to revoke any permit already issued, or to close the facility at any time, if in its opinion, it is the best interest of the City.

Hours of Operation:

7 days a week - 7:00 a.m. to 7:00 p.m.

and

7 days a week - 7:00 a.m. to 8:00 p.m. (Between Memorial Day and Labor Day)
